We have enjoyed watching our kids grow, and we are growing as an organization, too. This spring, we broke ground on our 13th branch and program support center. We received our largest-ever gift from the Bob & Renee Parsons Foundation in support of this new Club, and hosted the largest gala for Valley-only causes with Today's Kids, Tomorrow's Stars. 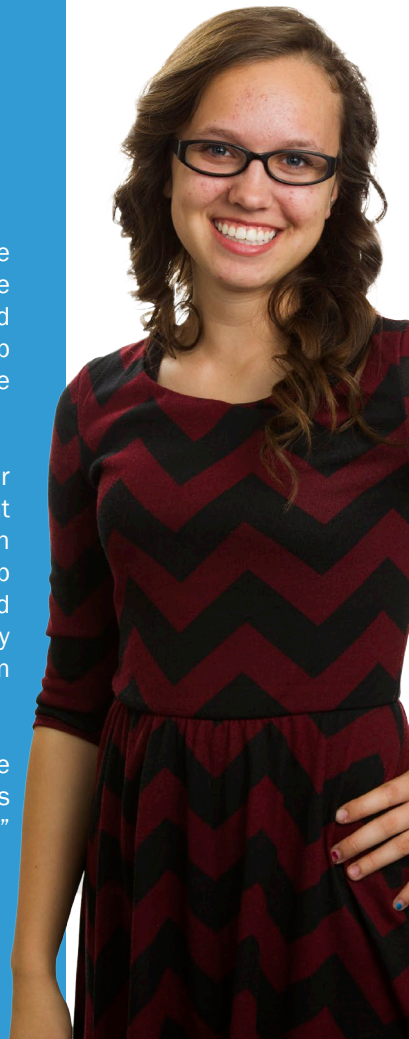

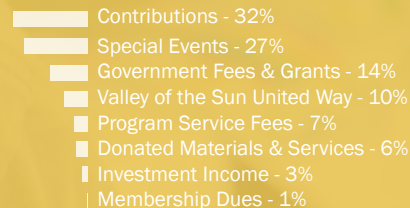
