## Arizona Qualified Charity Tax Credit (2026)

**\$506** SINGLE,  
MARRIED FILING SEPARATE  
OR HEAD OF HOUSEHOLD

**\$1,009** MARRIED  
FILING JOINT

**2025 tax credit limits:** \$495 single/\$987 joint

**EXAMPLE:** Mr. & Mrs. Smith give \$1,009 to Boys & Girls Clubs of the Valley. If they owed \$1,100 in Arizona state taxes, they will receive a credit for the \$1,009 and only owe \$91 in taxes.

Tax circumstances are different for everyone; please consult your tax advisor in order to receive the Arizona Qualifying Charitable Organization Tax Credit and/or Public School Tax Credit for the year. Please consult your tax advisor for federal income tax information.

**PLEASE NOTE:** Arizona law allows QCO donations made during 2025 (or made from January 1, 2026 through April 15, 2026) to be claimed on the 2025 Arizona income tax return. The maximum credit that can be claimed on the 2025 return for donations to QCOs is \$495 for single, married filing separate, or head of household taxpayers, and \$987 for married filing jointly taxpayers. If a taxpayer makes a QCO donation between January 1, 2026 and April 15, 2026 and wants to claim the 2026 higher credit, the taxpayer must claim that credit on the 2026 Arizona return filed in 2027. The maximum credit for QCOs in 2026: \$506 (single, married filing separate, head of household) and \$1,009 (married filing jointly). ([www.azdor.gov](http://www.azdor.gov))
